# Policy on Institutional Commitment to Competency Achievement and Social Accountability

## 1. Policy Statement

- Programs such as electives, service-learning, and outreach camps shall address underserved health issues.

- Collaborative projects with public health authorities, NGOs, and local government shall be pursued.
- Annual institutional reports will document how the education, service, and research missions align with local and national health needs.

#### 5.5 Monitoring and Evaluation

- Achievement of competencies shall be tracked through longitudinal assessments, including portfolios and workplace-based assessments.
- Social accountability indicators shall be included in program evaluation (e.g., graduate deployment, community feedback, health impact studies).
