Policy For Code of Conduct for Students

1. Discipline and Cleanliness

Discipline and cleanliness are core values that will not be compromised. Deliberate littering or spreading waste within hostel and college premises, using abusive language, or misbehaving with fellow hostel residents is strictly prohibited. Such behavior may result in disciplinary action.

2. General Conduct Expectations

They must demonstrate honesty and integrity in all academic and clinical settings. Students are required to maintain decorum across the campus, hostels, and affiliated institutions. Vandalism of college or hostel property is forbidden and will lead to disciplinary consequences.

5. Clinical Conduct
